The Request for Production of Documents sets forth documents which you must make available for your spouse's afterney to inspect, if you have the documents in your possession. I would like you to organize the documents and bring or send them to this office with your answers to the Interrogatories. I have also found that it saves staff time if the client organizes the requested documents in bundles that correspond to each of the numbered requests. For example, put all of the documents pertinent to Request No. 1 in one bundle, the documents for Request No. 2 into a separate bundle, etc. This organization would ultimately have to be done by the staff, and it is helpful, and will keep your costs down, if you have already assisted us by doing so.

You are technically obligated to provide the formal answers to the other attorney's office within thirty days from the date they have been received by my office. The documents were received on <a href="date">date</a>. Therefore, it would be helpful if you could organize your answers to the Interrogatories and the Production of Documents no later than <a href="date">date</a>.
