

Design Build Contract Agreement

1. Agreement	This agreement for Construction Services ("Agreement") is made between [Design Build Firm], LLC, d/b/a "[Design Build Firm]," located at _____ ("Firm"), and the undersigned ("Client") located at _____. Referenced together as "Parties" or individually as "Party". This Agreement shall commence on the date of the last Party to sign the Agreement ("Effective Date").
2. Services	Firm agrees to perform the services ("Services") as described in the Statement of Work ("SOW"), which is attached to this Agreement. Please review the SOW carefully to make sure that you fully understand the specific Services Firm is providing to you. You will notice that the cost for each Service is also included in the SOW.
3. Term	The term of this Agreement shall begin on the Effective Date and will continue in effect until the conclusion of any outstanding SOW ("Term"), unless terminated earlier as set forth below.
4. Termination	Firm and Client may terminate this Agreement immediately upon notice to for any reason or no reason. Upon termination, Firm shall cease performing Services and Client shall pay any outstanding amounts due. All in-process orders for materials shall be delivered to Client, subject to Client's payment of any balance which may be due.
5. Payment	Client will be required to provide a Deposit before Services are rendered. The Deposit will be \$_____. Client will be required to provide a weekly payment of \$_____. Throughout the duration of the project until all Services are rendered, Firm reserves the right to immediately stop work or cease providing Services, altogether if payments are not provided when due. If the Firm reasonably believes that a particular duty or responsibility is beyond that identified by this Agreement or the SOW then the Firm shall not be entitled to any amount which would result in an increase in the cost unless, prior to performing the subject duty or responsibility, the Firm has requested in writing a modification to this Agreement and the modification has been approved, in writing, by the Client.
6. Expenses	"Expenses" are amounts that Firm reasonably incurred during the provision of Services. Client agrees to reimburse Firm for all expenses including but not limited to: obtaining samples, parking, postage and handling, freight, printing, transportation, and storage costs. Firm will provide reasonable notice of material expenses when requested and where possible.
7. Insurance and Security	Client shall procure insurance against loss or damage for transport or storage of all Materials until delivery at Client's premises or other designated destination. Client shall have exclusive responsibility for risk of loss or damage. Client remains solely responsible for insuring its personal property. Firm strongly recommends the installation of security cameras and other monitoring features to secure the premises during the Project. The Firm shall maintain a professional liability insurance policy on a claims made basis, annual aggregate policy limit based on the following chart, unless modified in an attachment to this Agreement:
