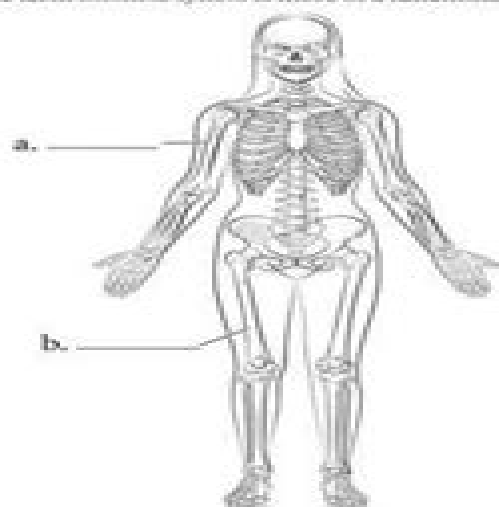


ORGAN SYSTEMS

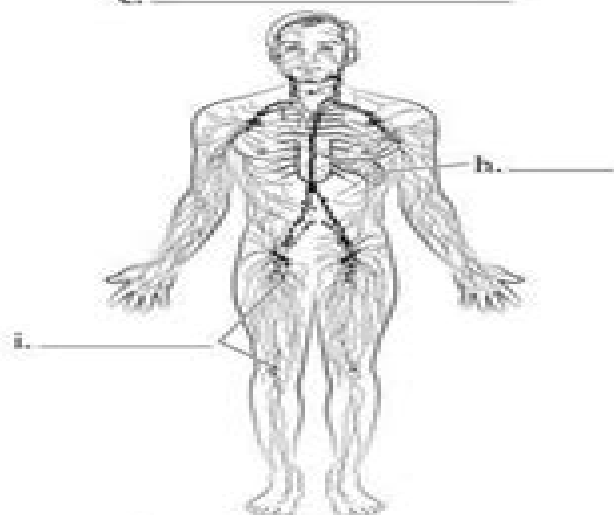
The human body is either studied by regions or by organ systems. This book uses the organ system approach in which individual organs (such as bones) are grouped into the larger organ systems (for example, the skeletal system). Typically eleven organ systems are described. The **skeletal system** consists of all of the bones of the body. Examples are the femur and the humerus. The **nervous system** consists of the nerves, spinal cord, and brain while the **lymphatic system** consists of lymph glands, conducting tubes called **lymphatics**, and organs such as the **spleen**. The term *immune system* is more of a functional classification

and will not be treated as a separate system here. The **muscular system** consists of individual skeletal muscles as organs such as the **pectoralis major** and **deltoid**. Label the organ systems underneath each illustration and label the selected organs by using the terms available. When you finish, select different colors for each organ system and color them in.

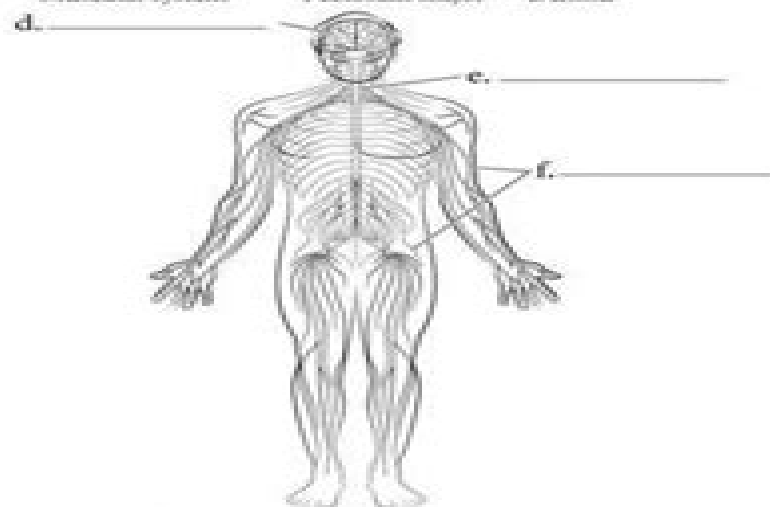

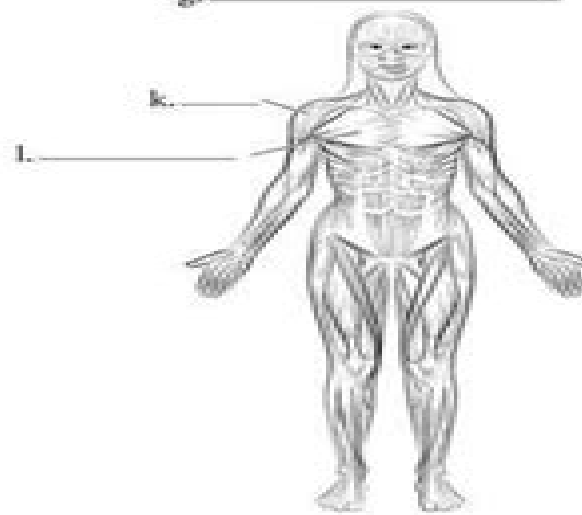
