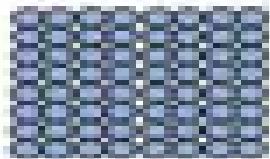

Particles in the solid state are still moving, but only very slightly. The movement appears more like a vibration.

- 11) What happens to the behavior gas particles when more and more heat is added?

As more heat is added to particles in the gas state, their movement becomes more disorderly and energetic. They bounce even more quickly against the container.

- 12) What is the most notable difference between particles in the solid phase and the liquid phase?

Particles in the liquid phase contain more energy from heat. This causes the particles to spread out more and spin more quickly than particles in the solid state.
