Questions with Answer - English Navneet Singh, Here are common corporate finance interview questions along with suggested answers Can you explain the concept of free cash flow and its importance Answer Free cash flow FCF is the cash generated by a company after accounting for capital expenditures It s important because it shows how much cash is available to return to shareholders pay off debt or reinvest in the business FCF is crucial for assessing a company s financial health and its ability to generate value for investors What is the difference between operating income and net income Answer Operating income is the profit a company makes from its core business operations excluding any non operating income and expenses Net income on the other hand is the total profit after all expenses including operating expenses interest taxes and non operating income expenses How do you calculate the weighted average cost of capital WACC Answer WACC is calculated by multiplying the cost of each capital component debt equity by its proportional weight and then summing the results The formula is $WACC = \frac{D}{V} R_d + \frac{E}{V} R_e$ Where E is the market value of equity D is the market value of debt V is the total market value of equity and debt Re is the cost of equity and Rd is the cost of debt What is the difference between an income statement and a cash flow statement Answer An income statement shows a company s revenues expenses and profits over a period focusing on profitability A cash flow statement however details the cash inflows and outflows from operating investing and financing activities providing insight into the company s liquidity and cash management Can you describe the concept of the time value
