#### Sample short answer test questions

#### Question 1

Explain what is meant by the term 'intertemporal choices' and give an example of an intertemporal choice.

#### Solution guidance

You would need to explain that intertemporal choices are decisions in one point in time that effect the choices available in future periods, so if you were to spend money now, that money would no longer available to meet expenditures in the future or for future investment. Be sure to answer all parts of the question and provide an example.

#### Question 2

What does it mean if a market is said to demonstrate 'pricing efficiency'? Why is it important for pricing to be efficient?

#### Solution guidance

There are several ways that this question could be approached, for example from an EMH perspective or by a comparison with Operational and Allocational efficiency. There many reason why pricing efficiency is important, one example is that it creates investor and corporate confidence that the prices are 'fair', which encourages market participation.

#### Question 3

What is the relationship between the nominal value and the price of a zero coupon bond? What factor(s) effect this relationship?

#### Solution guidance

A good answer would outline what these terms mean and explain how they are related via the discount rate/ yield.
