For example, put all of the documents pertinent to Request No. 1 in one bundle, the documents for Request No. 2 into a separate bundle, etc. This organization would ultimately have to be done by the staff, and it is helpful, and will keep your costs down, if you have already assisted us by doing so.

You are technically obligated to provide the formal answers to the other attorney's office within thirty days from the date they have been received by my office.
