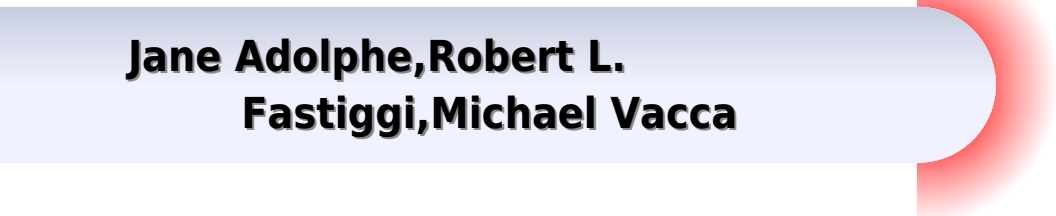
Abstract
