Treaty of Guadalupe-Hidalgo - ✓ ✓ got land from mexico, ended mexican american war, negotiated by trist

James Slidell - ✓ ✓ diplomat Polk sent to try to buy california for 20mill. ignored. (before mex-american war)

spot resolutions - ✓ ✓ Lincoln asked Polk to say the precise spot in which American Blood shed, because american blood was not shed in America but in disputed territory.

Harriet Tubman - ✓ ✓ United States abolitionist born a slave on a plantation in Maryland and became a famous conductor on the Underground Railroad leading other slaves to freedom in the North (1820-1913)

Zachary Taylor - ✓ ✓ Whig president who was a Southern slave holder, and war hero (mexican-american war), won the 1848 election, surprisingly did not address the issue of slavery at all on his platform. he died during his term and his vice president was millard fillmore.
