solvent front = 10

- A) 0.20

- D) 10 - Answer - The answer to this question is A (0.20) because R_f is the ratio of the distance travelled by the analyte relative to the solvent front during a chromatographic separation. Aspartic acid travelled two units, while the solvent front travelled ten units, giving an R_f of $2/10 = 0.20$ for aspartic acid.
