

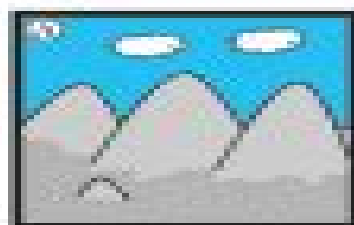

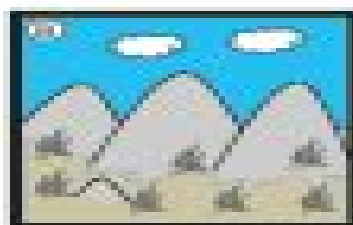
ES-OBJECTIVE: Distinguish how communities develop differently over time

QOC: May 18, 1980, Mount St. Helens in the state of Washington erupted with the force of a hydrogen bomb. The volcano had been dormant for over 130 years, but some 57 people were dead and forests and lakes were totally destroyed, including nearby Spirit Lake, which became a mud hole. The blast leveled trees in areas over 10 miles from the crater and ash deposits suffocated life on the mountain. However, within weeks, mammals that had taken shelter underground started to reappear in the area, and now, over thirty years later, many areas of the mountain are colonized with a large variety of plant and animal life. How does an area move from a sterile, barren wilderness to one full of life?

MODEL 1- PRIMARY SUCCESSION



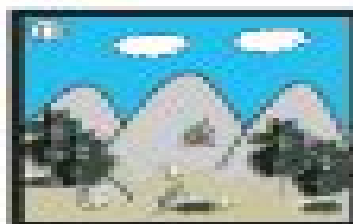
Barren rock flow beneath a retreating glacier, or due to a volcanic eruption.



Low-growing plants such as mosses, ferns, and lichens begin to colonize.



Fast-growing grasses, flowering plants, and small shrubs begin to colonize. A thin layer of soil develops.



Fast-growing trees such as birch and aspen begin to form a low forest and shade out lower plants.



100-200 years later, colonization begins. Slower-growing trees such as oak, beech, and redwood.
