APA Sample Interview Paper

As a prerequisite to finishing my discourse paper for University, I interviewed Professor Robert Wilson, a professor of Law and Political Science at Arthur McKnight University. My discipline for humanities is law. Even though Wilson does not teach in this field, he has a law degree, served as a lawyer, and has also taught courses related to the subject in the recent years. Therefore, it is given that he has a god understanding when it comes to writing in the subject of legalities. It turned out that he had also written some legal briefs regarding different lawsuits in representation to his clients, even publishing a law review article in 1999 (Wilson, 1999).

The interview was started by Wilson asking me which type of law I am planning to write about. I was not able to answer right away, because I was only planning to write about general law. I thought it would be quite similar with different fields of study under law. I informed him this and he informed me that there were different commonalities involving various types of law – environmental, criminal, civil rights, etc. However, the differences were highly significant too. I have emphasized that I was interested primarily in the noticeable characteristics, with which he told me they are fine (Wagner, 2011).

All throughout the interview, Wilson stopped several times to check on some legal books. This part during the interview was quite surprising to me. Wilson explained that the vocabulary that is used in the field of law is so technical and specialized that even seasoned lawyers have to check on the terms they use all the time (Chester, 2012). I told him that I thought this was what students learned in law school, but he said that law school teaches legal concepts. The main trick with vocabulary use is getting the right resources at hand.
