

Washington

Historical Context What are the immediate historical events that shaped/triggered this document? What is the environment of ideas, attitudes, + emotions behind the creation of the document?
The American conversation has been dominated by the French Revolution. Thomas Jefferson, the founder of the Democratic Republicans party, desired good ties with France so that, in the event of a conflict with the British, he could help them. The Jay Treaty established tight connections with the British, which the Hamiltonian Federalists desired since they were appalled by the French Revolution. Washington was chosen as the country's first president despite the fact that the United States was still in its infancy after its unsuccessful attempt at government with the Articles of Confederation. Some contentious choices were made during his administration, particularly Hamilton's financial plan. Nevertheless, he felt that it was time for him to leave office after serving two terms. Notably, Washington was concerned about the rise of political parties as a result of Hamilton's financial plan, the Jay Treaty, and his philosophical outlook.

George Washington wrote the document. As a founding father and American military leader, George Washington served as the country's first president from 1789 to 1797. Details in the document are included to reflect the author's point of view. Washington explains his concerns about political parties and international entanglements in unambiguous terms. Such subjects make it quite evident that they are from Washington's viewpoint. Additionally, the phrase "Friends and Fellow Citizens" emphasizes how a person in a position of responsibility is speaking to the public and addressing issues.

The major purpose of the text was to forewarn the United States about alliances and entanglements with other nations. Washington argues in his speech that the United States shouldn't intervene in European disputes and should instead maintain its neutral position in international issues. He does however stress the importance of international relations and trade. The fact that political parties are harmful and will cause division and sectionalism is another important point made by Washington. He exhorts Americans to forego the formation of political parties. The format of the text is very official.
