- D. You're usually required to advise a party in the matter.
- E. There is a legal forum involved such as a party seeking to institute an action at the court or seeking a legal remedy.

II. Preliminary reading of a problem question:

- Identify every party irrespective of whether or not they have a legal matter, whether or not they are your client to advise, whether or not they are the accused or victim (criminal case).
- 2. Identity the features and status quo of the parties.

Determine whether they are natural or artificial parties, married parties or belonging to the same family, citizen or foreigner, landlord or tenant, lessor or lessee, individual or state party (arm of government/institution).
