$$r^2 = \frac{G(128)(136)}{6.582 \times 10^{-10}}$$

$$r^2 = 1764.07$$

$$r = 42 \text{ m}$$

2. The force of gravity between two objects is 1200 N when the objects are 60 m apart. Find the force of gravity between the objects when they are 480 m apart.

Inverse square law:

Objects further apart, $F_g \downarrow$

$480 \div 60 = 8 \times$ further apart, so F_g is $8^2 = 64 \times$ smaller

$$1200 \div 64 = 18.8 \text{ N}$$

3. Two students are on a skateboards and push away from each other. A 48 kg student accelerates away at 2.6 m/s^2 . Find the acceleration of the other student if their mass is 32 kg. Action-reaction forces

$$F_{\text{net}} = ma$$

$$F_{\text{net}} = 48(2.6)$$

$$F_{\text{net}} = 124.8 \text{ N}$$

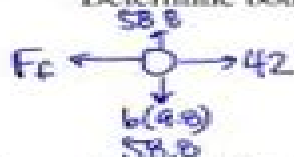
F_{net} is the same

$$F_{\text{net}} = ma$$

$$a = 3.9 \text{ m/s}^2$$

$$\mu = 0.153$$
