Consumer Protection in Choice of Law Giesela Ruhl,2011 Consumer protection in choice of law is a fairly young concept In fact the idea that consumers might be as much in need of protection in choice of law as in other areas of law did not loom large before the second part of the 20th century However after the consumer protection movement gained pace in the 1960ies and 1970ies academics courts and legislators were quick to transfer the concept into choice of law First legislative provisions were enacted in the 1970ies with 41 of the Austrian Act of Private International Law as well as Article 5 of the European Convention on the Law Applicable to Contractual Obligations Rome Convention In the 1980ies Switzerland followed suit with the adoption of Art 120 of the new Swiss Act on Private International Law Today consumer protection in choice of law is an integral part of legal systems around the world Thus it comes as a surprise that up to now the pertaining rules and regulations have received very little attention from economic theory Even though there is by now a substantial body of literature that deals with different aspects of conflict of laws from an economic perspective the question of whether
