connects over 200 entity types with clear semantics using more than 70 unique types of relationships We use this network to create collections of precise and specific types of knowledge and infer relationships not stated explicitly in the text but rather inferred from the large number of related sentences found in the literature This is exciting because it demonstrates that we are able to overcome the heterogeneity of written language and infer the correct semantics of the relationship described by authors Finally we can use this network to identify conflicting facts described in the literature to study change in language use over time and to predict drug drug interactions These achievements provide us with new ways of interacting with the literature and the knowledge embedded within it and help ensure that we do not bury the knowledge embodied in the publications but rather connect the often fragmented and disconnected pieces of knowledge spread across millions of articles in hundreds of journals We are thereby brought one step closer to the realization of personalized medicine and ensure that as scientists we continue to build on the knowledge discovered by past generations and truly to stand on the shoulders of giants
