#### REGULATION OF INVESTMENT ADVISERS, INCLUDING STATE-REGISTERED AND FEDERAL-COVERED ADVISERS

A person is not a minor, a dead person, or approprie declared mentally incompetent

A person meeting the three-prong test is an investment adviser (IA).

If a person is in the business of comparing the performance of one advisor against others for compensation, regionsmon as an LA is required.

A federal-covered LA fulling below \$90 million must register with the travels).

If any advisory clients are investment companies, the IA must be federally registered (SEC).

Lawyers, accountants, teachers, and engineers (LATE) are excluded from the definition of an IA as long as advice is incidental to the practice of the profession. Charging for the advice removes the exclusion. Sease erganered IAs qualify for an enemption under the de minimum rule (i.e., no place of business in the state and five or fraver areal clients).

With no place of business in the state, the IA can have an unlimited number of institutional clients without orginiering.

The anombird rule provides an earmption from registration for all securities professionals when dealing with variationing clients. Subject to 30-day rule for change of residence.

The term recomment counted can only be used by an IA whose principal business consists of rendering investment advice and a substantial portion of his advisory business involves investment supervisory services.

Under the Uniform Securities Act (USA), all performental registrations/withdrawals take place as moon, 30 days after completed application.

All registrations of persons expire on the first December 31 after registration, with annual renewal after that. However, registration of securities is effective for one year from the registration date.

A naccessor firm to a broker-dealer (BD) or IA does not pay a fee until the senewal date.

All professionals file a consent to service of process as a permanent part of their registration.

An LA currising discretion needs \$10,000 or worth or a narry bond. (USA)

An IA maintaining custody of customer fundal sociations needs \$35,000 ner worth or a surety bond. (USA)

If a state-covered IA recent the bonding, ner worth, or recordinging requirement of the IA's borne state, it suffices for any other state in which the IA is registered. Enderal-covered IA's meet SEC requirements only.

Under state and federal law, a possion is deerned to be in covered of an IA with an awasenhip level of at least 25%.

Company records, such as corporate charters or partnership agreements, must be maintained in the principal office of the LA or BD and preserved until at least three years after translitation of the correption.

#### REGULATION OF INVESTMENT ADVISER REPRESENTATIVES

An investment adviser representative (IAB) is an individual associated with an IA, including those who repervise IABs.

The de minimum exemption is available to an IAR with a state registreed IA.

There is no de minimis for IARs with a covered IA, but they only register in states where they have a place of business regardless of the number of chemic.

Under the USA: a solicitor for an investment advisory form who is paid a fee for his services must orginor at an IAR.

Under the USA, when an IAR leaves the employ of an IA, notification depends on whether the IA is federal covered or state registered. If state registered, only the IA notifies the Administrator, if Sederal covered, only the IAR notifies the Administrator.

#### REGULATION OF BROKER-DEALERS AND THEIR AGENTS

If a BD has an office in a scare, it must organer.

A BD exercising discretion or maintaining custody of customer funds/secutivies may have to post a surety bond unless the BD's net capital is in exercis of SEC requirements.

An agent exercising discretion (cannot have custody) may have to post a surery bond.

For a surery bond to meet the requirements of the USA, it must provide that any customer who

can prove a violation is entirled to collect against the bortel.

Anytime a commer deposits securities with a BD, a receipt for those correlates must be issued promptly.

Under the USA, when an agent premiumes association with a BD, both the agent and the BD must routly the Administrator promptly.

Any individual representing a BD in any form of securities offer or sale must be regionered.

Records may be kept on a computer disk than cannot be abored.

BD records muon be kept for there years and IA records for five years.

Material changes to a BD's orgintation must be reported promptly.

# REGULATION OF SECURITIES AND ISSUERS

The following are not socurities: retirement plans (IRAs, Koughal, norvaniable insurance contacts (fixed annuary, sense, whole life, modified endowment), collectibles, commodities (e.g., percious metals like gold), condominiums used as a personal residence, and currencies.

Securities Act of 1933: Registration of securities (Paper Act).

Nonexempt new issues can only be sold once the prospectus is effective. Indications of interest that no orders or money) can be scorped during the time the issue is "in registration" (before the effective distr).

USA: Security registered by qualification becomes effective only with an active review of importation.



Even if the security or the transaction is exempt, the agent of a BD must be properly registered.

A registered agent may accept an unsolicited order for a nonexampt unsegnment accurring because it is an exempt management. However, the Administrator retains the right to have theres as knowledge that the order was truly unsolicited.
