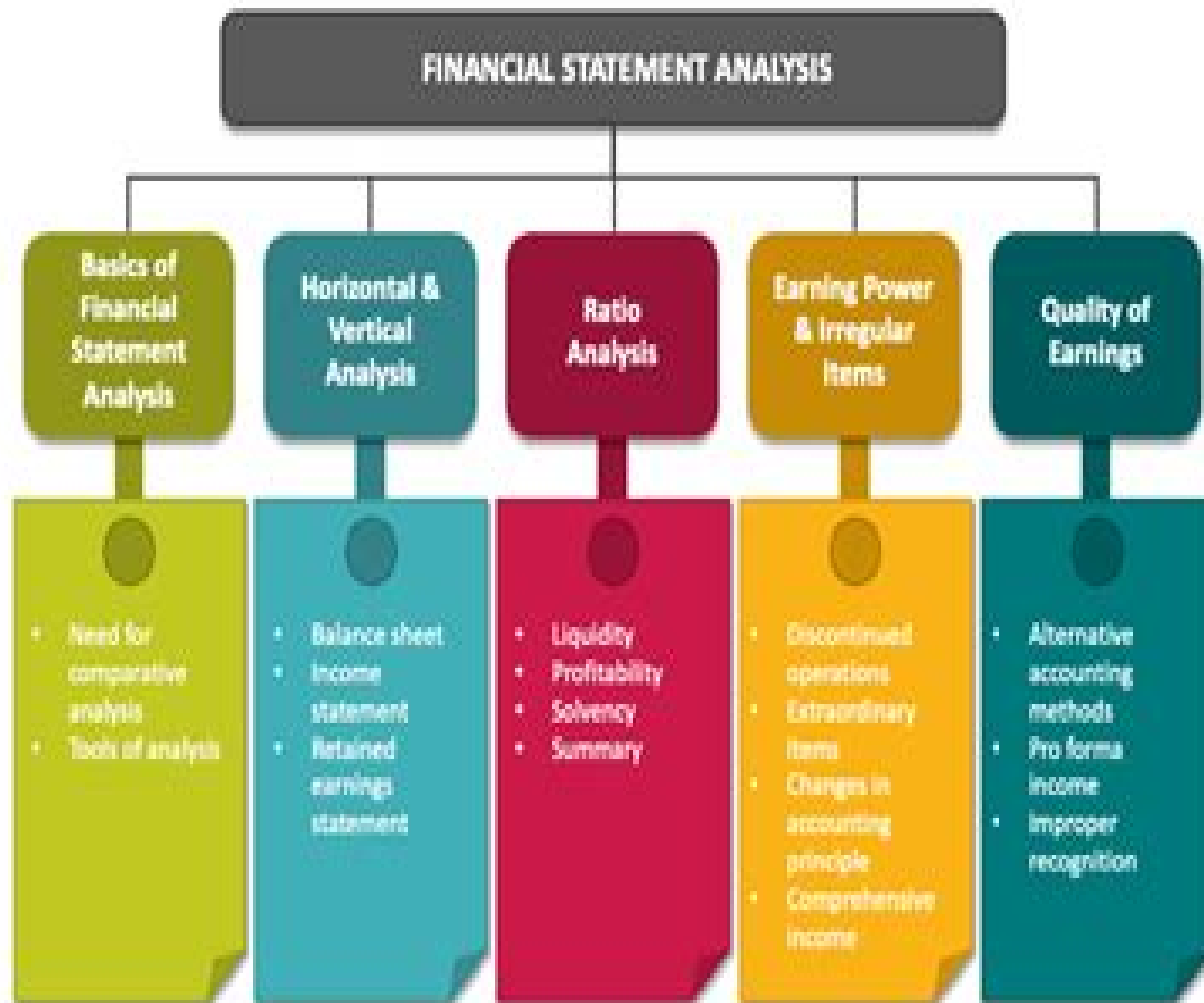

Qualitative Analysis Qualitative analysis involves considering non financial factors such as industry trends competitive dynamics management quality regulatory environment and macroeconomic conditions This analysis provides context and insights into the company's financial performance and outlook
