3. A football player kicks a football from ground level with an initial velocity of 27.0 m/s, 30° above the horizontal.

 - b. How long did it take the ball to return to the launching height? $t = 2.76 \text{ s}$
 - c. How far away did it land? $d_x = 64.5 \text{ m}$
4. A ball is launched with an initial velocity of 4.47 m/s at an angle of 66° above the horizontal.
 - a. What is the maximum height the ball attained? $.85 \text{ m} = d_y$
 - b. How long did it take the ball to return to the launching height? $t = .83 \text{ s}$
 - c. How far away did it land? $d_x = 1.51 \text{ m}$
5. A physics book slides off a horizontal table top with a speed of 1.10 m/s. It strikes the floor in 0.350 s. Find:
 - a. The height of the table above the floor. $d_y = .40 \text{ m}$
