During an A-P throw-in, thrower A-1 holds the ball through the boundary line plane and B-1 grabs it causing a held ball. The official resumes play by awarding the ball to Team A and rules this is still an A-P throw-in. Correct? - ANSWER-Yes

Prior to A-1 releasing the ball for a one and one, A-2 commits a common foul on B-2. Team B is in the bonus. Following A-1's free throws, the official awards B-2 and one and one. Correct? - ANSWER-No
