GPS Primary Lost showing on both ND's after IRU's align

If the GPS signal is not available after the IRU's align a possible fix is:

1. Data Key
2. Position Monitor
3. SEL NAVADS
4. Deselect *GPS showing (if SELECT *GPS is showing press LSK to change it)
