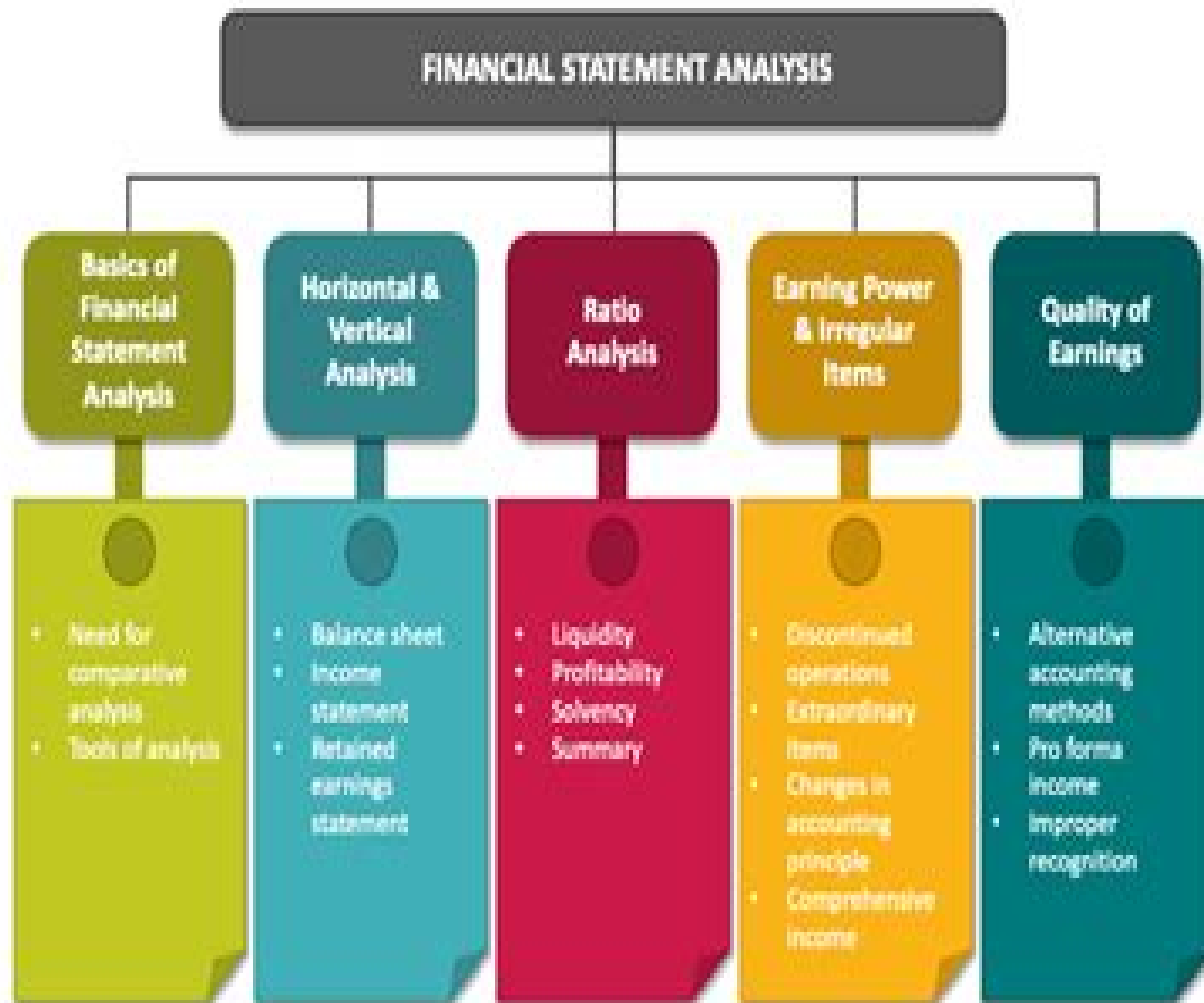

- Horizontal Analysis** Horizontal analysis, also known as trend analysis, involves comparing financial data over multiple periods to identify changes, trends, and growth rates. This analysis helps assess the company's performance and financial condition over time.
- Common Size Financial Statements** Common size financial statements express each line item as a percentage of a base figure, such as total revenue for the income statement or total assets for the balance sheet. This standardization allows for easier comparison of financial data across companies, industries, or time periods.
- DuPont Analysis** DuPont analysis breaks down the return on equity (ROE) into its component parts to identify the drivers of profitability. It decomposes ROE into the product of three ratios: net profit margin,

asset turnover and financial leverage This analysis helps identify areas for improvement in profitability and efficiency

**Cash Flow Analysis** Cash flow analysis involves examining the company's cash flows from operating investing and financing activities to assess its ability to generate cash invest in growth opportunities and meet financial obligations

**Comparative Analysis** Comparative analysis involves comparing the company's financial performance and position with its peers industry benchmarks or competitors This analysis helps identify strengths weaknesses opportunities and threats facing the company relative to its competitors

**Qualitative Analysis** Qualitative analysis involves considering non financial factors such as industry trends competitive dynamics management quality regulatory environment and macroeconomic conditions This analysis provides context and insights into the company's financial performance and outlook
