

How to answer legal problem questions

Preliminary points

1. Read the problem. Read it again. Read it slowly and make sure you have understood the facts.
Make a list of the key facts and put them in chronological order.
Do not speculate about the facts. Only deal with facts you have been given.
Do not repeat the facts. The marker has a copy of the question.
2. Identify the legal issues and make your own notes on the question paper.

How to write legal problem question answers

I R A C – in a snapshot

1. **Identify** the Issues
2. Explain the legal **R**ules
3. **Apply** the law to the question
4. **Conclusion**

I R A C – in slightly more detail

I = IDENTIFY THE LEGAL ISSUES

What are the main **issues** that the question deals with. You just **identify** them. No detail is required here as you are just identifying the legal issues. Make sure you identify the relevant issues. You need not spend more than a couple of sentences here.

R = EXPLAIN THE LEGAL RULES

The legal **rules** need to be explained in detail. Explain any legal terminology, explain the rules and how they operate. Back up the rules by referring to legal authority – cases and/or statutes. Make sure you explain all relevant issues. This part of the answer is very important and requires careful attention.

A = APPLY THE LAW TO THE FACTS

Here you will **apply** the law to the facts in detail. Please note that you are not repeating the law here. You are applying the law. You will bring out information from the scenario in doing so. So, you need to use the names of the parties and use the facts presented in a scenario and apply the law accordingly these. This part is also very important and requires careful attention.

C = CONCLUSION

This will include any advice you would give to the parties to the dispute or potential dispute. In this part you must not introduce new material. You will here express your conclusions and/or opinions. Spend no more than a short paragraph here.
