I believe Pharmagen should expense R&D costs as incurred. The number of funds provided by the other parties might exceed the entity’s liability.” Pharmagen needs to also disclose in the footnotes the terms of the royalty arrangements that it is to pay the PEI. ASC 730-20-50-1 – “An entity that under the provisions of this Subtopic accounts for its obligation under a research and development arrangement as a contract to perform R&D for others shall disclose both of the following: a. The terms of significant agreements under the research and development arrangement (including royalty arrange
